**Short Term Exposure:** Available data shows that this product is harmful, but symptoms are not available. ### Skin Contact

**Short Term Exposure:** Available data indicates that this product is not harmful. It should present no hazards in normal use. However product is believed to be mildly irritating, but is unlikely to cause anything more than mild transient discomfort.

Long Term Exposure: No data for health effects associated with long term skin exposure.

# Eye Contact

**Short Term Exposure:** This product may be absorbed through the eyes in harmful quantities. Symptoms are similar to those via other exposure routes. In addition product is very corrosive to eyes. It will quickly cause severe pain, and corrosion of the eye and surrounding facial tissues. Unless exposure is immediately treated, permanent blindness and facial scarring will occur.

### Ingestion

**Short Term Exposure:** Significant oral exposure is considered to be unlikely. This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other non hazardous ingredients are also possible.

The SWA TWA exposure value is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5 day working week. The STEL (Short Term Exposure Limit) is an exposure value that may be equalled (but should not be exceeded) for no longer than 15 minutes and should not be repeated more than 4 times per day. ### **Section 4 - First Aid Measures**

### **General Information:**

administered by trained personnel, preferably on a doctor's advice. DO NOT allow victim to move about unnecessarily. Symptoms of pulmonary oedema can be delayed up to 48 hours after exposure.

**Skin Contact:** Wash gently and thoroughly with water (use non-abrasive soap if necessary) for 10 minutes or until chemical is removed. If irritation persists, repeat flushing and obtain medical advice.

**Eye Contact:** Immediately flush the contaminated eye(s) with lukewarm, gently flowing water for at least 60 minutes, by the clock, while holding the eyelid(s) open. Neutral saline solution may be used as soon as it is available. DO NOT INTERRUPT FLUSHING. If necessary, keep emergency vehicle waiting (show paramedics this SDS and take their advice). Take care not to rinse contaminated water into the unaffected eye or onto face. Call a Poisons Information Centre or a doctor urgently. Take special care if exposed person is wearing contact lenses.

**Accidental release:** This product is sold in small packages, and the accidental release from one of these is not usually a cause for concern. # Section 7 - Handling and Storage

**Section 10 - Stability and Reactivity** 

**Reactivity:** Most strong acids react with inorganic and organic bases such as amines to form salts. They also react with many metals liberating hydrogen gas.
