4. FIRST AID MEASURES

If poisoning occurs, contact a doctor or Poisons Information Centre (Phone Australia 131 126, New Zealand 0800 764 766).

Inhalation: Remove victim from exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. Seek medical advice.

5. FIRE-FIGHTING MEASURES

Suitable extinguishing media: Alcohol resistant foam is the preferred fire-fighting medium. If material is involved in a fire use alcohol resistant foam, standard foam or dry agent (carbon dioxide, dry chemical powder).

Specific hazards: Non-combustible material.

7. HANDLING AND STORAGE

10. STABILITY AND REACTIVITY

Sensitisation: Inhalation: this material has been classified as not a respiratory sensitiser.

Skin: this material has been classified as not a skin sensitiser.

Tebuconazole caused reproductive toxicity in a two-generational rat study at dose levels that were toxic to the parent animals. A developmental toxicity study in rats produced an increased incidence of non-specific malformations and post implantation losses. These were observed at dose levels also causing maternal toxicity.

Specific target organ toxicity (repeat exposure): This material has been classified as non-hazardous.

12. ECOLOGICAL INFORMATION

Avoid contaminating waterways.

Acute aquatic hazard: This material has been classified as a Category Acute 1 Hazard.
