SECTION 4 FIRST AID MEASURES

FIRST AID TREATMENT

- **Swallowed:** DO NOT DELAY. Do NOT induce vomiting. If victim is alert, rinse mouth and drink 1/2 to 1 glass of water to help dilute the material. Seek immediate medical assistance.
- **Eve:** DO NOT DELAY. If in eyes, hold eyes open, flood with water for at least 15 minutes or until advised by the Poisons Information Centre / doctor.
- Skin:DO NOT DELAY. If spilt on skin or hair, immediately drench with running water and remove contaminated
clothing. Continue to wash skin and hair with plenty of water until advised to stop by the Poisons Information
Centre / doctor. For skin burns, cover loosely with a clean, dry, sterile dressing until medical help is available.Inhaled:Remove victim from exposure if safe to do so. If rapid recovery does not occur, transport to nearest medical

facility for additional treatment.

<u>First Aid facilities:</u> Potable water should be available to rinse eyes or skin. Provide eye baths and safety showers. **<u>Advice to Doctor:</u>** Treat symptomatically. **<u>Additional Information:</u>** None available.

SECTION 5 FIRE FIGHTING MEASURES

Specific Hazard: Reacts violently with water.

Product: DRAIN CLEANER

<u>Suitable Extinguishing Media:</u> Not combustible, however, if material is involved in a fire use: water fog or fine water spray, foam, dry chemical powder, carbon dioxide.

Hazards from combustion products: Decomposes on heating emitting toxic fumes.

<u>Precautions for Fire Fighters and Special Protective Equipment:</u> Wear full protective clothing and self-contained breathing apparatus.

Additional Information: Hazchem code 2R.

SECTION 6 ACCIDENTAL RELEASE MEASURES

Observe all local and national regulations.

Spills and Disposal: Clear area of all unprotected personnel. Wear protective equipment to prevent skin and eye contact and breathing dust. Work upwind or increase ventilation. Cover with damp absorbent (inert material, sand or soil). Sweep or vacuum up, but avoid generating dust. Collect and seal in properly labelled containers or drums for disposal. Caution – heat may be evolved on contact with water. If contamination of sewers or waterways has occurred advise local emergency services.

<u>Methods and Materials for Containment and Clean Up Procedures:</u> For small spills (<1 drum), transfer by mechanical means to a labelled, sealable container for product recovery or safe disposal. Allow any residues to evaporate or use an appropriate absorbent material and dispose of safely. For larger spills (> 1 drum), transfer by means such as a vacuum truck to a salvage tank for recovery or disposal. Do not flush residues with water. Retain as contaminated waste. Allow any residues to evaporate or use an appropriate absorbent material and dispose of safely.

SECTION 7 HANDLING AND STORAGE

<u>Precautions for Safe Handling and Storage:</u> Avoid skin and eye contact and breathing dust. Store in a cool, dry, well ventilated place out of direct sunlight. Store away from incompatible materials (see section 10). Keep containers closed when not in use – check regularly for spills. Before eating, drinking or smoking, remove contaminated clothing and wash hands. Do not eat, drink or smoke in contaminated areas.

Dispensing: No information available.

Flammability: Non-combustible material.
