## Section 4 - First Aid Measures

---

### General Information:

## Section 5 - Fire Fighting Measures

## Section 6 - Accidental Release Measures

---

**Accidental release:** This product is sold in small packages, and the accidental release from one of these is not usually a cause for concern. ---
