2. HAZARDS IDENTIFICATION

Based on available information, this material is not classified as hazardous according to criteria of Safe Work Australia.

This product is made from organic materials, including composted pinebark, and contains living microorganisms, including bacteria, fungi and protozoa. May also contain mineral and fertiliser additives.

Inhalation of dust and/or liquid mists may irritate, inflame or sensitise the nose, throat and lungs resulting in illnesses ranging from hayfever or asthma, to pneumonia (eg Legionnaire's disease) or pneumonia-like illnesses. Direct contact with this material or its dust and/or liquid mists (bioaerosols) may cause skin irritation (dermatitis), and skin or eye infection or irritation. 4. FIRST AID MEASURES

6. ACCIDENTAL RELEASE MEASURES

SMALL SPILLS

Wear protective equipment to prevent skin and eye contamination. Avoid inhalation of vapours or dust. Wipe up with absorbent (clean rag or paper towels). Collect and seal in properly labelled containers or drums for disposal.

LARGE SPILLS

Clear area of all unprotected personnel. Slippery when spilt. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contamination and the inhalation of dust. Work up wind or increase ventilation. Cover with damp absorbent (inert material, sand or soil). Sweep or vacuum up, but avoid generating dust. Collect and seal in properly labelled containers or drums for disposal. If contamination of crops, sewers or waterways has occurred advise local emergency services.

7. HANDLING AND STORAGE

Handling: Avoid eye contact and repeated or prolonged skin contact. Avoid inhalation of dust.

Storage: Store in a cool, dry, well-ventilated place and out of direct sunlight. Store away from foodstuffs. Store away from incompatible materials described in Section 10. Store away from sources of heat and/or ignition. Keep container standing upright. Keep containers closed when not in use - check regularly for spills.
