### DESCRIPTION

Crommelin<sup>®</sup> DiamondCoat<sup>®</sup> Solvent is a general purpose cleaning agent for application tools and equipment when used with Crommelin<sup>®</sup> DiamondCoat<sup>®</sup> sealers.

Crommelin<sup>®</sup> DiamondCoat<sup>®</sup> Solvent can be used to clean spills, degreasing substrates before sealing and thinning solvent based products.

Crommelin<sup>®</sup> DiamondCoat<sup>®</sup> Solvent also assists with removing solvent borne paints and sealers.

- Assists removal of excess wet and cured coatings.
- Aids in thinning and reworking coatings to increase penetration.

### AREAS OF USE

DiamondCoat<sup>®</sup> Solvent is suitable for:

- Thinning for solvent borne Crommelin<sup>®</sup> DiamondCoat<sup>®</sup> surface sealers. **Not recommended for use with Crommelin<sup>®</sup> DiamondCoat<sup>®</sup> Slate & Stone Sealer Natural and Crommelin<sup>®</sup> DiamondCoat<sup>®</sup> Paving & Concrete Sealer Natural.**
- Cleaning application equipment used in applying Crommelin<sup>®</sup> DiamondCoat<sup>®</sup> sealers.
- Removal of excess Crommelin<sup>®</sup> DiamondCoat<sup>®</sup> solvent borne sealer films; wet or cured.
- Reworking of cured coatings to increase penetration.
- Cleaning brushes after using solvent based paints and sealers.
- General purpose cleaning and degreasing.
- Reworking of cured coatings to release trapped moisture.

## SUITABLE SUBSTRATES

**DiamondCoat® Solvent** is suitable for use on surfaces as recommended by the appropriate Crommelin® DiamondCoat® Sealer.

## APPLICATION TOOLS

- Stiff bristle brush or broom.

## SURFACE PREPARATION

- Refer to the surface preparation guide of the appropriate Crommelin®.DiamondCoat® Sealer.

## APPLICATION PROCESS

- **Cleaning Equipment:** thoroughly wash any equipment with **DiamondCoat® Solvent** and allow to soak for 2 minutes. Rinse well with warm soapy water. Repeat if necessary.
- **Removing Existing Coatings:** It is recommended to work in manageable areas of 10m<sup>2</sup> at a time. Apply **DiamondCoat® Solvent** liberally and allow to soak for 2 minutes. Scrub with stiff bristle brush or broom then wash off with water before product dries.
- **Rework Existing Coatings:** If too much sealer has been applied or applied to damp substrate and whitening has occurred under the sealer. Apply **DiamondCoat® Solvent** liberally to the affected area. Work in with brush for several minutes until the surface exhibits a dark wet look. Allow to dry and repeat as necessary.

## PRECAUTIONS

- **Crommelin® DiamondCoat® Solvent** is a flammable aromatic solvent. Store in a cool place.
- Do not use in poorly ventilated areas. Keep container sealed when not in use.
- Do not apply during periods of extreme weather conditions – temperature or humidity. Apply between 5<sup>0</sup>c and 35<sup>0</sup>c and under 85% humidity. To check these conditions, refer to <http://www.bom.gov.au>
- Keep away from sources of ignition.

### Safety
