

FIXED DOOR INSTALLATION

Tools Required: Pencil, Ruler/Tape Measure, Utility Knife, Phillips Head Screwdriver, Set Square, Spirit Level, Wedges or spacers (cardboard from packaging can be used), Hammer, Sharp Chisel, Electric Drill, Drill Bits

After removing the packaging you'll have a Barrier door with hinges and latch assembly fixed in place and a small box which contains the rest of the latch furnishings, put this aside for later use.

1. Determine whether your door will be opening from the left or right and place the door into door frame with the grille facing out. Using wedges or spacers leave an approximate 3mm gap on all sides. (You may want a larger gap at the bottom to ensure the door opens freely.) **NOTE: NZ FIXED SECURITY DOOR IS LEFT OPENING ONLY.**
2. Once you have positioned door correctly, use a pencil to mark the top and bottom of the hinges on the door frame, then remove the door and wedges so you can continue marking the hinge position onto the inside of the door frame, use a set square to ensure the line is level.
3. Open the door hinges and align them with the lines marked on the inside of the door frame, hold door in place using wedges or get someone to help. With your screw driver fix one screw in the oval hole of the top hinge. Check the door opens and closes freely. If you need to adjust the height loosen the screw and slide it up and down as needed if not place another screw in the oval hole of the bottom hinge. Open and close the door again to double check operation, make any adjustments as required then fix remaining screws to hinges.
4. Open the box containing the rest of the latch assembly and striker plates.
NOTE: FOLLOW THE INSTRUCTIONS PROVIDED WITHIN THE BOX FOR LATCH ASSEMBLY.
5. Fitting the Striker Plates – Lock the door whilst open, then close the door and mark the top and bottom of the lock bolt positions on the frame. Open the door and place the striker plates on the pencil marks, then trace the shape of the striker plate and screw holes onto the frame. Drill two small pilot holes for the screws, now chisel out the marked rectangle to a depth of 20mm and (if required) the outlined area to a sufficient depth to allow the striker plate to sit flush with the door jamb. Fit the striker plate with the two screws, check that the lock bolt engages properly into the striker plate. Now check that the door can be locked and unlocked with the snib.

Finally check that the door can be locked and unlocked from inside and out. Then your door is ready for use.

Limited Manufacturer's Warranty

Our Goods come with guarantees that cannot be excluded under the Australian Consumer Law. You are entitled to a replacement or refund for a major failure. - 3.1 Be able to show that the damage or defect has arisen solely from faulty materials or workmanship;
- 3.2 Be able to show that the product has not been misused, mistreated, damaged or neglected by physical means including but not limited to fair wear and tear, accidents or act of God after purchase;
- 3.3 Be able to show that it has fulfilled its product maintenance obligations;
- 3.4 Be able to show that the Product has not been used in a manner inconsistent with the prescribed purpose;
- 3.5 Be able to show that the Product has not at any time been:
 - a) attached to; nor
 - b) fixed to; nor
 - c) installed such that it is touching;

Any other metallic objects or materials which are not aluminium;

- 3.6 Be able to show that it was the original purchaser by production of the original receipt of purchase clearly showing the Date of Purchase;
- 3.7 Be able to show that the Date of Purchase was less than one year before the claim of warranty.
- 3.8 Pay all the transportation charges incurred in returning the defective Product (or parts thereof) for repair, together with the cost of returning them to the purchaser.

Other Important Information in relation to the Warranty

- 4.1 The Liability of the Supplier pursuant to this Warranty is (to the extent it is lawful to do so) limited to the cost of repair or replacement of the Product. The supplier shall not in any circumstances be liable for physical or financial injury, loss or damage or for consequential loss or damage of any kind arising from the product or its use or application by the purchaser.
- 4.2 This Warranty is non-transferable and does not apply to any purchaser who bought the product from a reseller or distributor not authorised by the supplier, including but not limited to purchases from internet auction sites
- 4.3 Should the product prove to be irreparable, the supplier reserves the right to substitute an equivalent product if available or to retract the Warranty if no replacement is available.
- 4.4 The benefits provided to the purchaser by the warranty are in addition to other rights and remedies available to the purchaser

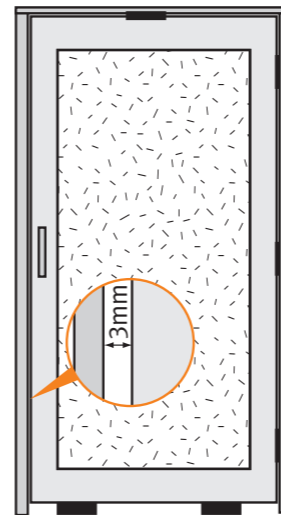

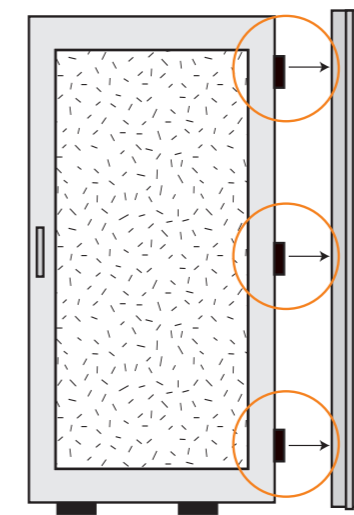

B = BARRIER

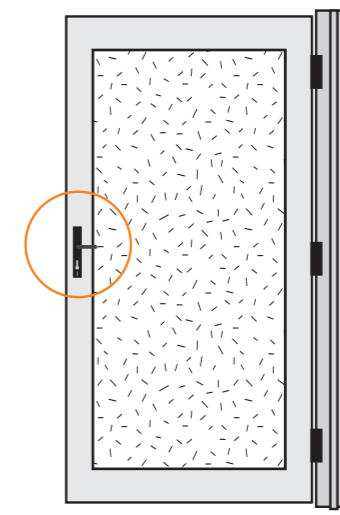
S = SECURITY



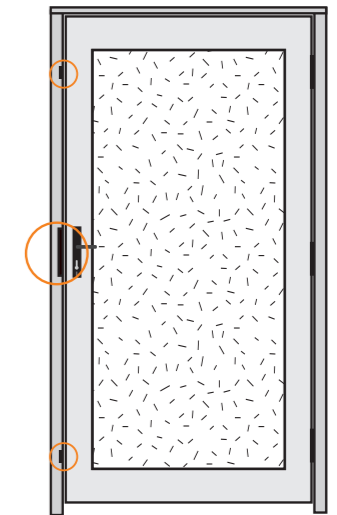
Place wedges top and bottom of door so there is a 3mm gap between door and frame, mark hinge position.



Open door and prop level and aligned with marks on frame for hinges, then fix.



Fit Latch.



Fit striker plate/s.
B Single lock
S Triple locks

Definitions:
