## 4. FIRST AID MEASURES

### Inhalation:

Remove victim from area of exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. Seek medical advice if effects persist.

### Skin Contact:

If skin contact occurs, remove contaminated clothing and wash skin with running water. If irritation occurs seek medical advice.

### Eye Contact:

If in eyes, wash out immediately with water. In all cases of eye contamination it is a sensible precaution to seek medical advice.

## **Ingestion:**

Rinse mouth with water. If swallowed, give a glass of water to drink. If vomiting occurs give further water. Seek medical assistance.

## **5. FIRE FIGHTING MEASURES**

### **Hazards from combustion products:**

Not combustible, however following evaporation of the water component of the material, the residual material can burn if ignited. On burning will emit toxic fumes.

### **Precautions for fire fighters and special protective equipment:**

Fire fighters to wear self-contained breathing apparatus and suitable protective clothing if risk of exposure to vapour or products of combustion.

### **Suitable Extinguishing Media:**

Not combustible, however, if material is involved in a fire use: Fine water spray, normal foam, dry agent (carbon dioxide, dry chemical powder).

## **6. ACCIDENTAL RELEASE MEASURES**

### **Emergency procedures:**

If contamination of sewers or waterways has occurred advise local emergency services.

### **Methods and materials for containment and clean up:**

Slippery when spilt. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contact. Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). Collect and seal in properly labelled containers or drums for disposal.

## **7. HANDLING AND STORAGE**

### **Conditions for safe storage:**

Store in cool place and out of direct sunlight. Keep containers closed when not in use - check regularly for leaks.

### **Precautions for safe handling:**

Avoid skin and eye contact and breathing in vapour, mists and aerosols.

## 11. TOXICOLOGICAL INFORMATION

**Ingestion:** No adverse effects expected, however, large amounts may cause nausea and vomiting.

**Inhalation:** Where this material is used in a poorly ventilated area, at elevated temperatures or in confined spaces, vapour may cause irritation to mucous membranes of the respiratory tract, headache and nausea. Breathing in mists or aerosols may produce respiratory irritation.

**Long Term Effects:**

No information available for the product. Repeated or prolonged breathing of crystalline silica dust may result in chronic lung diseases such as silicosis. However, due to the physical state of this product this is not relevant unless it is sanded, abraded or crushed. In such cases, precautions should be taken to avoid the breathing of dust.

**Toxicological Data:** No LD50 data available for the product.
