## **Section 2 - Hazards Identification**

#### **Statement of Hazardous Nature**

This product is classified as: Xi, Irritating. Hazardous according to the criteria of SWA.

Not a Dangerous Good according to the Australian Dangerous Goods (ADG) Code.

Risk Phrases: R36. Irritating to eyes.

Safety Phrases: S23, S24/25. Do not breathe vapours or mists. Avoid contact with skin and eyes.

SUSMP Classification: None allocated.

ADG Classification: None allocated. Not a Dangerous Good under the ADG Code.

#### **Emergency Overview**

#### Physical Description & Colour: Liquid - no further details available.

Odour: Slight odour.

**Major Health Hazards:** 2-butoxyethanol is a severe eye irritant. Results of skin irritation studies are conflicting; however, it is considered to be a mild to moderate skin irritant in test animals. Contact dermatitis has been reported in a few cases. It is well absorbed via the inhalational, oral and dermal routes. eye irritant.

## **Potential Health Effects**

#### Inhalation:

**Short Term Exposure:** Available data indicates that this product is not harmful. In addition product is unlikely to cause any discomfort or irritation.

Long Term Exposure: No data for health effects associated with long term inhalation.

## Skin Contact:

**Short Term Exposure:** Available data indicates that this product is not harmful. It should present no hazards in normal use. However product may be irritating, but is unlikely to cause anything more than mild transient discomfort. **Long Term Exposure:** No data for health effects associated with long term skin exposure.

## **Eye Contact:**

**Short Term Exposure:** This product is an eye irritant. Symptoms may include stinging and reddening of eyes and watering which may become copious. Other symptoms may also become evident. If exposure is brief, symptoms should disappear once exposure has ceased. However, lengthy exposure or delayed treatment may cause permanent damage.

Long Term Exposure: No data for health effects associated with long term eye exposure.

## Ingestion:

**Short Term Exposure:** Significant oral exposure is considered to be unlikely. However, this product is an oral irritant. Symptoms may include burning sensation and reddening of skin in mouth and throat. Other symptoms may also become evident, but all should disappear once exposure has ceased.

Long Term Exposure: No data for health effects associated with long term ingestion.

## **Carcinogen Status:**

SWA: No significant ingredient is classified as carcinogenic by SWA.

**NTP:** No significant ingredient is classified as carcinogenic by NTP.

**IARC:** 2-butoxyethanol is Class 3 - unclassifiable as to carcinogenicity to humans.

This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other non hazardous ingredients are also possible.

The SWA TWA exposure value is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5 day working week. The STEL (Short Term Exposure Limit) is an exposure value that may be equalled (but should not be exceeded) for no longer than 15 minutes and should not be repeated more than 4 times per day. There should be at least 60 minutes between successive exposures at the STEL. The term "peak "is used when the TWA limit, because of the rapid action of the substance, should never be exceeded, even briefly.

#### **Section 4 - First Aid Measures**

## **General Information:**

You should call The Poisons Information Centre if you feel that you may have been poisoned, burned or irritated by this product. The number is 13 1126 from anywhere in Australia (0800 764 766 in New Zealand) and is available at all times. Have this MSDS with you when you call.

**Inhalation:** First aid is not generally required. If in doubt, contact a Poisons Information Centre or a doctor. **Skin Contact:** Wash gently and thoroughly with water (use non-abrasive soap if necessary) for 5 minutes or until chemical is removed.

**Eye Contact:** Immediately flush the contaminated eye(s) with lukewarm, gently flowing water for 20 minutes or until the product is removed, while holding the eyelid(s) open. Take care not to rinse contaminated water into the unaffected eye or onto the face. Obtain medical attention immediately. Take special care if exposed person is wearing contact lenses.

# **Section 5 - Fire Fighting Measures**

**Fire and Explosion Hazards**: The major hazard in fires is usually inhalation of heated and toxic or oxygen deficient (or both), fire gases. There is no risk of an explosion from this product under normal circumstances if it is involved in a fire.

## **Section 6 - Accidental Release Measures**

**Accidental release:** This product is sold in small packages, and the accidental release from one of these is not usually a cause for concern. **Storage:** Make sure that containers of this product are kept tightly closed. Keep containers of this product in a well ventilated area. Section 10 - Stability and Reactivity

**Reactivity:** This product is unlikely to react or decompose under normal storage conditions. However, if you have any doubts, contact the supplier for advice on shelf life properties.

**Conditions to Avoid:** Keep containers tightly closed. Keep containers and surrounding areas well ventilated. **Incompatibilities:** acids, strong oxidising agents.

**Fire Decomposition:** Only small quantities of decomposition products are expected from this product at temperatures normally achieved in a fire. This will only occur after heating to dryness. Combustion forms carbon dioxide, and if incomplete, carbon monoxide and smoke. Water is also formed. May form oxides of sulfur (sulfur dioxide is a respiratory hazard) and other sulfur compounds. Most will have a foul odour. May form oxides of phosphorus and other phosphorus compounds. Sodium compounds. Carbon monoxide poisoning produces headache, weakness, nausea, dizziness, confusion, dimness of vision, disturbance of judgment, and unconsciousness followed by coma and death.

Insufficient data to be sure of status. Expected to not be an environmental hazard.

Vapour phase glycols are expected to degrade fairly rapidly by reaction with hydroxyl radicals (eg half-life 32 hours for propylene glycol). Removal from air by rainfall is possible.

WATER: Should degrade relatively rapidly via biodegradation.

SOIL: If released to soil, relatively rapid biodegradation should also occur. Leaching to groundwater may occur.
