## **Potential Health Effects**

## Inhalation:

**Short Term Exposure:** Available data indicates that this product is a severe inhalation irritant. Symptoms may include headache, extreme irritation of nose and throat and increased secretion of mucous in the nose and throat. Other symptoms may also become evident, and may last long after exposure has ceased. If liquid enters nasal passages, it will cause pain and burn nasal membranes. ## **Section 4 - First Aid Measures**

#### **General Information:**

You should call **The Poisons Information Centre** if you feel that you may have been poisoned, burned or irritated by this product. **The number is 13 11 26** from anywhere in Australia (0800 764 766 in New Zealand) and is available at all times. Have this SDS with you when you call.
