## 2. HAZARDS IDENTIFICATION

## 4. FIRST AID MEASURES

### Inhalation:

Remove victim from area of exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. If patient finds breathing difficult and develops a bluish discolouration of the skin (which suggests a lack of oxygen in the blood - cyanosis), ensure airways are clear of any obstruction and have a qualified person give oxygen through a face mask. Apply artificial respiration if patient is not breathing. Seek immediate medical advice.

### **Skin Contact:**

### 6. ACCIDENTAL RELEASE MEASURES

### **Emergency procedures:**

### Methods and materials for containment and clean up:

SMALL SPILLS: Slippery when spilt. Avoid accidents, clean up immediately. Collect in a container for disposal via special chemical waste collection.

LARGE SPILLS: Shut off all possible sources of ignition. Slippery when wet. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contact. Avoid breathing in vapours. Work up wind or increase ventilation. Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). Collect and seal in properly labelled containers or drums for disposal.

## 7. HANDLING AND STORAGE

### Conditions for safe storage:

Store in a well ventilated area away from foodstuffs, oxidising agents and sources of heat or ignition. Keep containers closed when not in use - check regularly for leaks.

### Precautions for safe handling:

Keep out of reach of children. Avoid skin and eye contact and breathing in vapour. All potential sources of ignition (open flames, pilot lights, furnaces, spark producing switches and electrical equipment etc) must be eliminated both in and near the work area. Do NOT smoke. Vapour may travel a considerable distance to source of ignition and flash back.

## **10. STABILITY AND REACTIVITY**

## **11. TOXICOLOGICAL INFORMATION**

No adverse health effects expected if the product is handled in accordance with this Safety Data Sheet and the product label. Symptoms or effects that may arise if the product is mishandled and overexposure occurs are:

Ingestion:	Swallowing can result in nausea, vomiting and central nervous system depression. If the victim is showing signs of central system depression (like those of drunkeness) there is greater likelihood of the patient breathing in vomit and causing damage to the lungs. Breathing in vomit may lead to aspiration pneumonia (inflammation of the lung).
Eye contact:	May be an eye irritant.
Skin contact:	Contact with skin will result in irritation. Will have a degreasing action on the skin. Repeated or prolonged skin contact may lead to irritant contact dermatitis.
